1. Changes in the Competition Programme are published:

16.02.2018, Friday

from 20:00 Limited service (1:30), overnight Parc Ferme.
The same in clause 10 Service Parks, Vs “B” Service Park.

17.02.2018, Saturday

Start of the 2nd leg / PF exit (for the first participant) – 8:20
SS2 start (for the first participant) – 8:35

18.02.18, Sunday

Start of the 3rd leg / PF exit (for the first participant) – 8:20
SS4 start (for the first participant) – 8:35

2. Changes to clause 1.1, clause 12.5, clause 12.6, and clause 17 are published.

A liaison between the Service Park “A” and the Parc Ferme “A” is canceled. Parc Ferme “A” is transferred to Helyulya village, Airport, near the Service Park “A”.

Point V6 is simultaneously an exit from the Service Park and the entrance to the Parc Ferme.

Clause 12.6 Parc Ferme “A” shall be read as follows: “After the Service Park provided for changing wheels, Parc Ferme “A” (Aerodrome, Helyulya village) will be arranged. The following time control points will be set:

- V6 Exit from the Service Park / Entrance to the Parc Ferme
- TC0 – exit from the Parc Ferme / Start of the 1st leg.

Delay to TC 6 will be penalized in accordance with clause 12.5. Penalization for late / early at TC0 (exit from the Parc Ferme / Start of the 1st leg) in accordance with clause 38 of the FIA Regulations.

3. Changes to Section 1.4. Location of start and finish of the competition are published:

The competition start – Sortavala, Helyulya Aerodrome.

The competition finish - Vyartsilya, “Gardarika” Resort

4. Changes to Section 1.6 Stewards of the Meeting:

Due to force majeure reasons, Anita Passalis is replaced by Raymond JOHANSSON as FIA Steward. Nevertheless, Raymond Johansson will also keep his position as FIA Observer.

5. Changes to Section 2.6. Officials of the competition are published:

The post of Competitor Relations Officer assistant is abolished.

The post of RAF Observer is abolished.

The post of FIA Technical Delegate Assistant is abolished

The post of International Press Officer is abolished

6. Addition to Section 9- Fuel is published:

Clause 9.3 Refuelling vehicles during the competition is allowed at the regular petrol stations and in the equipped Refueling Area, indicated in the Road Book.

The Refuelling Area will be placed in the Vs “B” and Vs “C” Service Park and indicated in the Road Book.

Vehicles should have a fuel autonomy (without refuelling) of 350 km.

7. Changes to section 10. Service parks are published:

After the tyres changing in the Service Park “A” (Aerodrome, Helyulya village), the service cars should move to the site in front of the Parc Ferme “B” (Ruskeala village) and then to the Service Park “B” (Vyartsilya village)

8. Changes to Section 15. SSS are published:

SSS (SS1) about 19 km long is planned.

9. Changes to Section 16.5. Special stages (SS) are published:

b). If the crew exceeds the maximum time at SS2, it can start at SS3, upon receiving the check mark at the TC “regrouping entrance” before 12:30, 17.02.18;
